2 A RESOLUTION OF THE BOARD OF COUNTY
3 COMMISSIONERS OF BROWARD COUNTY, FLORIDA,
4 AUTHORIZING APPROPRIATION AND DISBURSEMENT
5 OF FISCAL YEAR 2021-2022 FUNDS IN THE AMOUNT OF
6 \$835,000 TO SPECIFIED SERVICE PROVIDERS FOR THE
7 PROVISION OF SERVICES FOR BROWARD COUNTY
8 YOUTH EXPERIENCING MENTAL HEALTH CONDITIONS;
9 AUTHORIZING THE COUNTY ADMINISTRATOR TO
EXECUTE AMENDMENTS TO EXISTING AGREEMENTS
WITH THE SPECIFIED SERVICE PROVIDERS AND TAKE
ALL NECESSARY ADMINISTRATIVE AND BUDGETARY
ACTIONS TO IMPLEMENT THE AGREEMENTS AS
AMENDED; AND PROVIDING FOR SEVERABILITY AND AN
EFFECTIVE DATE.

10 WHEREAS, the Board of County Commissioners of Broward County, Florida
11 (“Board”), desires to appropriate and disburse funding to specified service providers for
12 the provision of services for Broward County youth experiencing mental health conditions
13 for fiscal year 2021-2022 (“FY22”);

14 WHEREAS, on September 9, 2021, the Board approved FY22 funding for the
15 provision of these services and now desires to increase funding to specified service
16 providers with existing agreements;

17 WHEREAS, the Board further desires to authorize the Broward County
18 Administrator (“County Administrator”) to execute, on behalf of the County, amendments
19 to existing agreements with the specified providers for services for Broward County youth
20 who are experiencing mental health conditions and those at risk of involvement or
21 involved in the juvenile justice system who are experiencing mental health conditions;
22 and

23 WHEREAS, the Board finds that these services benefit the residents of Broward
24 County and serve a public purpose, NOW, THEREFORE,

1 BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF
2 BROWARD COUNTY, FLORIDA:

4 Section 1. Authorized Appropriation and Disbursement.

5 The Board hereby authorizes appropriation and disbursement of FY22 funds in the
6 aggregate amount of Eight Hundred Thirty-five Thousand Dollars (\$835,000), as set forth
7 in Attachment A.

8 Section 2. Execution by the County Administrator.

9 The County Administrator is hereby authorized to execute amendments effective
10 October 1, 2021, increasing funding of existing agreements with each of the service
11 providers, as specified in Attachment A. The County Administrator is further authorized
12 to take all necessary administrative and budgetary actions to implement the agreements
13 as amended. Nothing in this Resolution alters the requirement that agreements be
14 reviewed for legal sufficiency by the Office of the County Attorney before execution. Any
15 material deviations from the applicable Board-approved form agreement must be
16 presented to the Board for approval.

17 Section 3. Severability.

18 If any portion of this Resolution is determined by any court to be invalid, the invalid
19 portion will be stricken, and such striking will not affect the validity of the remainder of this
20 Resolution. If any court determines that this Resolution, in whole or in part, cannot be
21 legally applied to any individual, group, entity, property, or circumstance, such
22 determination will not affect the applicability of this Resolution to any other individual,
23 group, entity, property, or circumstance.
