

RESOLUTION DIRECTING THE COUNTY ADMINISTRATOR TO
PUBLISH NOTICE OF PUBLIC HEARING TO CONSIDER ADOPTION OF A
RESOLUTION AMENDING THE BROWARD COUNTY ADMINISTRATIVE CODE

1 BE IT RESOLVED by the Board of County Commissioners of Broward County,
2 Florida, that:

3 Section 1. The County Administrator in and for Broward County, Florida, and
4 ex officio Clerk of the Board of County Commissioners of Broward County is authorized
5 and directed to publish notice of intent of the Board of County Commissioners of Broward
6 County to consider at public hearing on September 8, 2022, at 10:00 a.m., the adoption
7 of a Resolution Amending the Broward County Administrative Code, the title of which is

17 ("ADMINISTRATIVE CODE"), TO "TARIFF NO. 5, FOREIGN-
18 TRADE ZONE NO. 25"; REPEALING AND REPLACING
19 TARIFF NO. 4, FOREIGN TRADE ZONE NO. 25, ATTACHED
20 AS EXHIBIT 42.B AND INCORPORATED IN SECTION 42.29
OF THE ADMINISTRATIVE CODE, WITH TARIFF NO. 5,
FOREIGN-TRADE ZONE NO. 25, AS ATTACHED, WHICH
AUTHORIZES THE CHIEF EXECUTIVE AND PORT
DIRECTOR TO EXECUTE FTZ AGREEMENTS THAT DO
NOT EXCEED FIVE YEARS AND TO SUBMIT
APPLICATIONS FOR MINOR BOUNDARY MODIFICATIONS
TO THE FTZ BOARD, ADDS A NEW FTZ USER
APPLICATION FEE, AND PROVIDES FOR GENERAL
UPDATES TO TARIFF TEXT; AND PROVIDING FOR
SEVERABILITY, INCLUSION IN THE ADMINISTRATIVE
CODE, AND AN EFFECTIVE DATE.

21 Section 2. Such notice shall be made pursuant to the applicable provisions of
22 Section 3.04 of the Broward County Charter.

23 Section 3. This Resolution will take effect upon adoption.
