2 A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF BROWARD
3 COUNTY, FLORIDA, PERTAINING TO PORT EVERGLADES FOREIGN-TRADE ZONE
4 (“FTZ”) NO. 25, TARIFF NO. 4 (“TARIFF”); RENAMING PART IV OF CHAPTER 42 AND
5 SECTION 42.29, BOTH TITLED “TARIFF NO. 4, FOREIGN TRADE ZONE NO. 25,” OF
6 THE BROWARD COUNTY ADMINISTRATIVE CODE (“ADMINISTRATIVE CODE”), TO
7 “TARIFF NO. 5, FOREIGN-TRADE ZONE NO. 25”; REPEALING AND REPLACING
8 TARIFF NO. 4, FOREIGN TRADE ZONE NO. 25, ATTACHED AS EXHIBIT 42.B AND
9 INCORPORATED IN SECTION 42.29 OF THE ADMINISTRATIVE CODE, WITH TARIFF
10 NO. 5, FOREIGN-TRADE ZONE NO. 25, AS ATTACHED, WHICH AUTHORIZES THE
11 CHIEF EXECUTIVE AND PORT DIRECTOR TO EXECUTE FTZ AGREEMENTS THAT
12 DO NOT EXCEED FIVE YEARS AND TO SUBMIT APPLICATIONS FOR MINOR
13 BOUNDARY MODIFICATIONS TO THE FTZ BOARD, ADDS A NEW FTZ USER
14 APPLICATION FEE, AND PROVIDES FOR GENERAL UPDATES TO TARIFF TEXT;
15 AND PROVIDING FOR SEVERABILITY, INCLUSION IN THE ADMINISTRATIVE CODE,
16 AND AN EFFECTIVE DATE.

17 WHEREAS, the Board of County Commissioners of Broward County, Florida
18 (“Board”), desires to rename Part IV of Chapter 42 and Section 42.29, both titled “Tariff
19 No. 4, Foreign Trade Zone No. 25,” of the Broward County Administrative Code
20 (“Administrative Code”), to “Tariff No. 5, Foreign-Trade Zone No. 25;” and repeal and
21 replace Tariff No. 4, Foreign Trade Zone No. 25, attached as Exhibit 42.B and
22 incorporated in Section 42.29 of the Administrative Code, with Tariff No. 5, Foreign-Trade

23 Zone No. 25, as attached, which authorizes the Chief Executive and Port Director to
24 execute FTZ Agreements that do not exceed five (5) years and to submit applications for
25 Minor Boundary Modifications to the FTZ Board, adds a new FTZ User Application Fee,
26 and provides for general updates to Tariff text; and

27 WHEREAS, the Board has determined that the revisions, as set forth herein, are
28 necessary and in the best interests of Broward County, NOW, THEREFORE,

29 BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF
30 BROWARD COUNTY, FLORIDA:

31 Section 1. Part IV of Chapter 42 and Section 42.29, both titled "Tariff No. 4,
32 Foreign Trade Zone No. 25," of the Broward County Administrative Code, are hereby
33 renamed "Tariff No. 5, Foreign-Trade Zone No. 25."

34 Section 2. Tariff No. 4, Foreign Trade Zone No. 25, attached as Exhibit 42.B
35 and incorporated in Section 42.29 of the Broward County Administrative Code, is hereby
36 repealed in its entirety, and Tariff No. 5, Foreign-Trade Zone No. 25, as attached, is
37 hereby adopted.

38 Section 3. Severability.

39 If any portion of this Administrative Code Resolution is determined by any court to
40 be invalid, the invalid portion will be stricken, and such striking will not affect the validity
41 of the remainder of this Administrative Code Resolution. If any court determines that this
42 Administrative Code Resolution, in whole or in part, cannot be legally applied to any
43 individual, group, entity, property, or circumstance, such determination will not affect the
