

RESOLUTION DIRECTING THE COUNTY ADMINISTRATOR TO  
PUBLISH NOTICE OF PUBLIC HEARING TO CONSIDER  
ENACTMENT OF AN ORDINANCE

1 BE IT RESOLVED by the Board of County Commissioners of Broward County,  
2 Florida, that:

3 Section 1. The County Administrator in and for Broward County, Florida, and  
4 ex officio Clerk of the Board of County Commissioners of Broward County is authorized  
5 and directed to publish notice of intent of the Board of County Commissioners of Broward  
6 County to consider at public hearing on October 11, 2022, at 10:00 a.m., the enactment  
7 of an Ordinance, the title of which is as follows:

8 AN ORDINANCE OF THE BOARD OF COUNTY COMMISSIONERS OF BROWARD  
9 COUNTY, FLORIDA, PERTAINING TO THE REPEAL OF OBSOLETE OR OUTDATED  
10 PROVISIONS IN CHAPTER 1 OF THE BROWARD COUNTY CODE OF ORDINANCES  
11 (“CODE”); REPEALING SECTION 1-6 RELATING TO THE PURCHASE OF UNIFORMS  
12 FOR CERTAIN BROWARD COUNTY EMPLOYEES, SECTION 1-8 RELATING TO  
13 PUBLIC INFORMATION ON THE ENERGY CRISIS, SECTION 1-12 RELATING TO  
14 ELECTRONIC ACCESS TO PUBLIC RECORDS, SECTION 1-20 RELATING TO THE  
15 EXECUTION OF AGREEMENTS WITH SECOND PARTIES, SECTION 1-21 RELATING  
16 TO THE TIME LIMITATION ON BRINGING MATTERS BEFORE THE BOARD OF  
17 COUNTY COMMISSIONERS, AND SECTION 1-46 RELATING TO INDEMNIFICATION  
18 CLAUSES IN FEDERAL PROJECT CONTRACTS; AND PROVIDING FOR  
19 SEVERABILITY, INCLUSION IN THE CODE, AND AN EFFECTIVE DATE.

22 Section 125.66, Florida Statutes.
