

**THIRD AMENDMENT TO AGREEMENT NO. V2112712P1 BETWEEN BROWARD COUNTY AND VECTOR
MEDIA HOLDING CORP d/b/a VECTOR MEDIA TRANSIT, LLC
FOR THE TRANSIT ADVERTISING PROGRAM**

This is the Third Amendment ("Third Amendment") to the Agreement (defined below) between Broward County, a political subdivision of the State of Florida ("County"), and Vector Media Holding Corp d/b/a Vector Media Transit, LLC ("Contractor" and each a "Party" or collectively the "Parties").

RECITALS

- A. County and Direct Media, Inc. entered into Contract No. V2112712P1, dated April 4, 2017, as amended by the First Amendment, dated April 29, 2020, Contract Update Notification, dated April 19, 2021, and Second Amendment, dated April 26, 2022 ("Agreement").
- B. On February 22, 2018, the County approved the assignment of the Agreement from Direct Media, Inc. to Contractor.
- C. The Agreement expires by its terms on October 31, 2022.
- D. County issued Request for Proposal ("RFP") Number TRN2122974P1 seeking to engage a firm under a new agreement for the Transit Advertising Program and needs additional time to complete the RFP process and execute a new agreement.
- E. County and Contractor desire to extend the term of the Agreement on a month-to-month basis to the earlier of (i) October 31, 2023, or (ii) the effective date of County's notice of termination for convenience pursuant to Section 8.1 of the Agreement.

Now, therefore, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties hereto agree as follows:

- 1. The Agreement is hereby ratified and confirmed, and the term is hereby extended on a month-to-month basis to the earlier of either (a) October 31, 2023, or (b) the effective date of County's notice of termination for convenience pursuant to Section 8.1 of the Agreement.
- 2. The effective date of this Third Amendment shall be the date of complete execution by both Parties. This Third Amendment, together with the Agreement, represents the final and complete understanding of the Parties regarding the subject matter of the items addressed herein, and supersedes all prior and contemporaneous negotiations regarding that subject matter. There is no commitment, agreement, or understanding concerning the subject matter of this Third Amendment that is not contained in this Third Amendment or the Agreement.
- 3. This Third Amendment may be executed in counterparts, each of which shall be deemed to be an original, but all of which, taken together, shall constitute one and the same agreement.
- 4. Each individual executing this Third Amendment on behalf of a party hereto hereby represents and warrants that they are, on the date they sign this Third Amendment, duly authorized by all necessary and appropriate action to execute this Third Amendment on behalf of such party and does so with full legal authority.
