

In 2019, the Broward Sheriff's Office purchased and issued BCM Patrol Rifles to every sworn Department of Law Enforcement Deputy to ensure deputies are appropriately equipped for situations requiring a force multiplier, such as a tactical rifle. As the Broward Sheriff's Office has gone since 2019, the purchase of 100 more rifles and accessories is needed to continue to equip the deputies for an Active Killer/Mass Casualty Critical Incident response.


