2 AN ORDINANCE OF THE BOARD OF COUNTY COMMISSIONERS OF BROWARD  
3 COUNTY, FLORIDA, PERTAINING TO THE REPEAL OF OBSOLETE OR OUTDATED  
4 PROVISIONS IN CHAPTERS 15, 17, 21, AND 23 OF THE BROWARD COUNTY CODE  
5 OF ORDINANCES ("CODE"); REPEALING SECTION 15-5 RELATING TO THE  
6 ESTABLISHMENT OF A WISHING WELL, SECTIONS 15-6 THROUGH 15-9 RELATING  
7 TO ANNUAL APPROPRIATIONS TO VARIOUS ENTITIES, SECTION 15-12 RELATING  
8 TO THE APPROPRIATION AND DISBURSEMENT OF COUNTY FUNDS TO  
9 NONPROFIT ORGANIZATIONS, CHAPTER 17 RELATING TO JUNK AND JUNK  
10 DEALERS, ARTICLE X OF CHAPTER 21 RELATING TO CONVENIENCE STORE  
11 SECURITY, AND SECTION 23-1 RELATING TO REQUIRED EQUIPMENT FOR  
12 BICYCLES; AND PROVIDING FOR SEVERABILITY, INCLUSION IN THE CODE, AND  
13 AN EFFECTIVE DATE.

16 BE IT ORDAINED BY THE BOARD OF COUNTY COMMISSIONERS OF  
17 BROWARD COUNTY, FLORIDA:

18 Section 1. Section 15-5 of the Broward County Code of Ordinances, titled  
19 "Wishing well for benefit of society for crippled children and adults authorized," is hereby  
20 repealed in its entirety.

21 Section 2. Section 15-6 of the Broward County Code of Ordinances, titled  
22 "Annual appropriation to Broward County Opportunity Center," is hereby repealed in its  
23 entirety.

24 Section 3. Section 15-7 of the Broward County Code of Ordinances, titled  
25 "Annual appropriation to Henderson Clinic," is hereby repealed in its entirety.

26 Section 4. Section 15-8 of the Broward County Code of Ordinances, titled  
27 "Annual appropriation to Fair Haven of Broward County, Inc.," is hereby repealed in its  
28 entirety.

29 Section 5. Section 15-9 of the Broward County Code of Ordinances, titled  
30 "Annual appropriation to Children's Rehabilitative Services or similar organizations," is  
31 hereby repealed in its entirety.

32 Section 6. Section 15-12 of the Broward County Code of Ordinances, titled  
33 "Certain nonprofit organizations declared assets; funding by county a public purpose," is  
34 hereby repealed in its entirety.

35 Section 7. Chapter 17 of the Broward County Code of Ordinances, titled "Junk  
36 and Junk Dealers," is hereby repealed in its entirety.

37 Section 8. Article X of Chapter 21 of the Broward County Code of Ordinances,  
38 titled "Convenience Store Security," is hereby repealed in its entirety.

39 Section 9. Section 23-1 of the Broward County Code of Ordinances, titled  
40 "Required equipment for bicycles," is hereby repealed in its entirety.

41 Section 10. Severability.

42 If any portion of this Ordinance is determined by any court to be invalid, the invalid  
43 portion will be stricken, and such striking will not affect the validity of the remainder of this

44 Ordinance. If any court determines that this Ordinance, in whole or in part, cannot be  
45 legally applied to any individual, group, entity, property, or circumstance, such  
46 determination will not affect the applicability of this Ordinance to any other individual,  
47 group, entity, property, or circumstance.

48 Section 11. Inclusion in the Broward County Code of Ordinances.

49 It is the intention of the Board of County Commissioners that the provisions of this  
50 Ordinance become part of the Broward County Code of Ordinances as of the effective  
51 date. The sections of this Ordinance may be renumbered or relettered and the word  
52 "ordinance" may be changed to "section," "article," or such other appropriate word or  
53 phrase to the extent necessary in order to accomplish such intention.

54 Section 12. Effective Date.

55 This Ordinance is effective as of the date provided by law.
