A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF BROWARD COUNTY, FLORIDA, ADOPTING THE BROWARD COUNTY TRANSIT DEVELOPMENT PLAN 2023-2032 ANNUAL UPDATE; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, Section 341.052, Florida Statutes, created the public transit block grant administered by the Florida Department of Transportation ("FDOT");

WHEREAS, Rule 14-73.001, Florida Administrative Code ("F.A.C."), titled "Public Transit," sets forth FDOT's requirements for recipients of public transit block grant funds;

WHEREAS, pursuant to Rule 14-73.001, F.A.C., Broward County is required to prepare a Transit Development Plan ("TDP") as its planning, development, and operational guidance document, based on a ten (10) year planning horizon;

WHEREAS, Broward County is required to submit annual TDP updates to FDOT in the form of progress reports documenting, among other things, the past year's accomplishments, analysis of any discrepancies between the plan and its implementation for the past year and steps that will be taken to attain original goals and objectives, a revised implementation program for the tenth year, and added recommendations for the new tenth year of the updated plan;

WHEREAS, the Broward County Transportation Department has developed the Broward County Transit Development Plan 2023-2032 Annual Update, which, if approved by FDOT, will provide an estimated Eleven Million Two Hundred Seventy-four Thousand
