



The name of the Corporation is WFn Holdings, Inc."


3. The Corporation's Board of Directors duly approved the foregoing Certificate of Amendment of Articles of Incorporation.

The foregoing Certificate of Amendment of Articles of Incorporation has been duly approved by unanimous vote of the stockholders of the Corporation in accordance with Sections 902 and 903 of the California Corporations Code. The total number of issued and outstanding shares of the Corporation is One Million Seven Hundred Sixty Five Thousand Three Hundred Seventy Seven (1,765,377) shares of Common Stock and Six Hundred Fifty Thousand (650,000) shares of Series A Preferred Stock. There are no other shares of stock of the Corporation issued and outstanding. The number of shares voting in favor of this amendment equaled or exceeded the vote required. The percentage vote required was more than fifty percent (50%) of the outstanding shares of Common Stock and Series A preferred Stock, voting together as one class.
