The Town of Southwest Ranches is in receipt of an application to amend the Non-Vehicular Access Line shown on the TARA Plat by closing the platted openings on Southwest 184th Avenue and creating a 50-foot-wide right-in, right-out opening on Griffin Road at the Northwest corner of Lot 1. The Town of Southwest Ranches has no objection to the proposed amendment more specifically described as follows:


- 1) Amend the NVAL along Griffin Road, per the attached sketch and legal description, to allow for a permanent right-in, right-out condition along the south limits of the road easement abutting the south right-of-way line of Griffin Road at the Northwest corner of Lot 1.
- 2) Amend the NVAL along Southwest 184th Avenue, per the attached sketch and legal description, to eliminate the two 50-foot access openings along the west limits of the road easement abutting the west right-of-way line of Southwest 184th Avenue, between lots 1 and 2 and lots 3 and 4, and to eliminate the east-west portions of the existing NVAL extending west from said access openings.
- 3) Eliminate a portion the NVAL line along the west limits of the road easement per the attached sketch and legal description, lying in the southerly portion of Lot 4 and easterly portion of Parcel "A," designed for a future right turn lane adjacent to the right-of-way of Southwest 184th Avenue, to include the NVAL along the north right-of-way line of the unnamed dedicated right-of-way, commonly known as Southwest 49th Street.

4) Eliminate the NVAL along the south right-of-way line and along the north right-of-way line of the unnamed dedicated right-of-way, commonly known as Southwest 49th Street to include the north and south corner chords.

5) Amend the NVAL to eliminate the full-access opening on Southwest 184th Avenue at the unnamed dedicated right-of-way, commonly known as Southwest 49th Street, per the attached sketch and legal description
