#### Requested Action

MOTION TO ADOPT Resolution providing for Fiscal Year 2023 assessment rates and amounts for a non-ad valorem special assessment to be imposed on private hospitals in Broward County to help finance the non-federal share of the State of Florida’s Medicaid program (“Special Assessment”).

#### Why Action is Necessary

Broward County Local Provider Participation Fund Ordinance, Article V of Chapter 16 of the Broward County Code of Ordinances, provides for the Board to adopt a rate resolution for the Special Assessment.

#### What Action Accomplishes

This action approves the non-ad valorem assessment rates and amounts to be levied on private for-profit and not-for-profit hospitals that provide inpatient hospital services.

#### Summary Explanation/Background

Pursuant to the Broward County Local Provider Participation Fund Ordinance, codified in Article V of Chapter 16 of the Broward County Code of Ordinances (“Ordinance”), the Broward County Board of

County Commissioners will convene a public hearing to discuss, consider, and take action on a resolution setting the rate of collection and assessment amount for a non-ad valorem special assessment on local private hospitals ("Special Assessment"), which Special Assessment is due on November 30, 2022.

The Special Assessment is intended to finance intergovernmental transfers, provided consistent with federal guidelines, that fund the non-federal share of certain Medicaid and/or Medicaid managed care payments. The Special Assessment directly and specially benefits the assessed properties and supports the provision of health care services to uninsured persons and those who qualify for Medicaid.

Notice of this Public Hearing has also been provided to the owners of the Assessed Properties in accordance with the Ordinance.

**Fiscal Impact/Cost Summary**

This action will levy a special assessment on private for-profit and not-for-profit hospitals at their request that provide inpatient hospital services in Broward County. The FY23 Special Assessment will generate \$24,094,673, which will be sent to the State less \$100,000 the County will retain to cover administrative costs.
