Pursuant to Section 163.3184, Florida Statutes, as amended, Broward County Comprehensive Plan amendments shall be adopted by Ordinance by the Broward County Board of County Commissioners, serving as the local governing body.

County Land Use Plan Natural Resource Map Series, pursuant to Section 163.3184, Florida Statutes, as amended.

April 26, 2022 - The County Commission approved transmittal of proposed Broward County Land Use Plan amendment PCNRM 22-1 to designated State review agencies; and August 25, 2022 - Set adoption Public Hearing for September 8, 2022.
