The Resolution directs the County Administrator to set a public hearing for September 8, 2022, to consider transmittal of proposed text amendment PCT 22-2, which is an amendment to the Broward County Land Use Plan, to designated State review agencies pursuant to Section 163.3184, Florida Statutes, as amended.
