Summary Explanation/Background

This proposed Ordinance revises the regulatory requirements for certain for-hire transportation services regulated through the Environmental and Consumer Protection Division ("ECPD"). The proposed changes address a number of issues regarding vehicles for hire, including regarding availability of dispatch services and outstanding fines and fees by applicants.

The Ordinance, if enacted, would require that each holder of a Certificate of Public Necessity and Convenience identify the dispatch service it uses, and would require each dispatch service to register and to operate 24 hours a day, seven days a week. In addition, the Ordinance would require vehicle for hire permit holders and registered chauffeurs to pay all outstanding fines and fees prior to application for or renewal of their respective permits or registrations. The proposed Ordinance includes fines in excess of \$500 for violations of the dispatch services requirements, and therefore approval of the Ordinance at the public hearing would require approval by a majority plus one of the Board.
