Summary Explanation/Background

REGIONAL EMERGENCY SERVICES AND COMMUNICATIONS AND THE EMERGENCY MANAGEMENT SECTION RECOMMEND APPROVAL OF THE ABOVE MOTIONS.

In accordance with the Robert T. Stafford Disaster Relief and Emergency Assistance Act, as amended, 42 U.S.C. 5121-5207, as authorized by Section 662 of the Post Katrina Emergency Management Reform Act, the Emergency Management Performance Grant (EMPG) funds may be used for all-hazards emergency management operations, staffing, and other planning, training, or coordination activities as specified in the EMPG Fiscal Year 2021 Scope of Work.

Retroactive approval is requested, as the grant agreement was received after July 1, which is the start of the State fiscal year. Based on Fiscal Year legislative appropriations, Broward County's Federal EMPG award this Fiscal Year is \$366,937. The award must be expended by June 30, 2022. This sub-grant agreement requires a dollar-for-dollar non-Federal match. The grant funding will be utilized to support four existing positions within the Emergency Management Section.

Fiscal Impact

Fiscal Impact/Cost Summary

The total amount of the EMPG award is \$366,937. The County will be reimbursed for costs not to exceed \$366,937 for the EMPG award. The County's in-kind match, in the amount of \$366,937 has been budgeted within the Emergency Management Section's general fund account.
