# Why Action is Necessary

Board of County Commissioners' approval is required, at a public hearing, to set rates per Section 34-6 of the Broward County Code of Ordinances. The Broward County Charter requires the posting of notice and a public hearing for adoption of amendments to the County Administrative Code.

Provides for the public hearing required to amend Section 38.18 of the Broward County Administrative Code to revise current water and wastewater rates, fees, and charges.

#### Summary Explanation/Background

PUBLIC WORKS DEPARTMENT/WATER AND WASTEWATER SERVICES RECOMMENDS APPROVAL.

Broward County provides retail water and wastewater services to approximately 58,000 customers throughout the County's Water and Wastewater Services service area. The recommended Fiscal Year 2023 operating and capital program budgets for the Water and Wastewater Fund include increases in water and wastewater retail rates effective for services rendered on or after October 1, 2022. The new rates are necessary to fund operating costs, debt service costs, and cash-financed capital. The proposed Fiscal Year 2023 rates reflect an overall increase in water revenue of 5.72% and sewer revenue of 1.91%, for a cumulative overall revenue increase of 3.98%. An average residential customer using 5,000 gallons of water per month will experience an overall increase of \$2.25 (3.13%) in their monthly water and wastewater bill, from \$71.79 to \$74.04. All miscellaneous fees remain the same.

This action has been reviewed and approved by the Office of Management and Budget.
