RECOMMEND APPROVAL OF THE ABOVE MOTION.

This action will correct an increase to the previously approved funding to reflect the intended budgeted funding in Agreement No. 22-CP-HIP-6886-01 between Broward County and TaskForce ("Agreement").

On June 7, 2022 (Item No. 9), the Commission approved funding in the amount of \$48,691 to TaskForce for the purchase of updated equipment and accessories for street outreach services via Resolution. The Resolution did not indicate an amendment, only referenced the Agreement number. On June 14, 2022, (Item No. 7, Motion F), the Commission approved a funding increase in the Agreement that did not reflect the funds previously allocated to TaskForce.
