**Previous Action Taken**

The Board previously approved \$81,892 from numerous public and private individuals and entities to be donated to the Delta Education and Life Development Foundation, Inc. in Ms. Henry's honor. Additional donations were made, totaling \$5,000, that were not included in the previous resolution that was approved by the Board.

**Summary Explanation/Background**

Motion A authorizes a donation in the amount of \$5,000 to a scholarship fund established in Ms. Henry's honor at Delta Education and Life Development Foundation, Inc. ("DELDF"). The Board previously approved a donation to the scholarship fund in the amount of \$81,892 to DELDF made from numerous public and private individuals and entities. Additional donations were made totaling \$5,000, that were not included in the previous donation to DELDF that was approved by the Board.

Motion B is a budget resolution appropriating the donation of \$5,000 which includes recognizing the transactions in Motion A.
