Summary Explanation/Background

The Broward County Local Provider Participation Fund Ordinance ("LPPF Ordinance") as set forth in Article V of Chapter 16 of the Broward County Code of Ordinances allows for the imposition of a uniform non-ad valorem special assessment upon private hospitals in Broward County ("Hospitals") to help finance the non-federal share of the State of Florida's Medicaid program ("Special Assessment").

The proposed Ordinance amends the LPPF Ordinance by streamlining and modifying certain procedures the Hospitals must follow for the annual imposition of the Special Assessment. If certain conditions are met, the proposed amendments will allow the Hospitals the option to submit to the County a release of liability agreement in lieu of an indemnification, hold harmless, and release of liability agreement now required under the LPPF Ordinance. In addition, to reduce the administrative burden on County staff, the proposed amendment provides for the appointment of a single point of contact for the Hospitals to collect and provide to the County all documentation required for the imposition of the Special Assessment.

This public hearing has been advertised with adequate notice to allow the Board's consideration of this item on August 25, 2022.
