Broward County Board of County Commissioners' approval is required to authorize the County Administrator to approve the acceptance of the Grant award for funding under the Fiscal Year 2022 Port Security Grant Program and take the necessary budget actions.

Allows for funding of high priority security enhancements at Port Everglades that were identified and approved by the U.S. Coast Guard Captain of the Port and the Miami Area Maritime Security Committee.

**Summary Explanation/Background**

THE PORT EVERGLADES DEPARTMENT RECOMMENDS APPROVAL.

This item supports the Broward County Board of County Commissioners' ("Board") Value of "Ensuring economic opportunities for Broward's diverse population and businesses" and the Goal to "Increase the economic strength and impact of revenue generating County enterprises balancing economic, environmental, and community needs."

The Broward County Port Everglades Department has been identified as eligible for a U.S. Department of Homeland Security ("DHS"), Federal Emergency Management Agency ("FEMA") grant under the Federal Fiscal Year 2022 Port Security Grant Program ("PSGP") in an amount of \$1,977,326 to fund specific priorities to address the prevention of, protection against, response to, and recovery from, incidents or other natural or man-made disasters (to include all hazard compatibility) affecting the Port Everglades Port Area. The grant complements previous PSGP awards that the Port Everglades Department has used to update and improve the overall quality of layered security infrastructure. This grant will provide second phase funding to construct and equip a second floor to the existing Security Operations Center and relocate the Port Everglades Security Data Center to an elevated second floor location to mitigate risk of flooding and enhance the facility's overall resiliency. The project is a continuation from the initial programming and design phase funding provided by a 2018 Port Security Grant approved by the Board on October 8, 2018 (Item No. 13).

Funding for critical projects approved by the U.S. Coast Guard and FEMA require a 25% cost share (\$659,109) from Broward County. Total estimated project cost for the approved security project, including the County matching funds, is \$2,636,435.

The Grant Award Letter was posted for approval on the FEMA Grants website on September 21, 2022 (see Exhibit 1).
