The 2024 International Cricket Council Men's T20 World Cup, an international Twenty20 cricket tournament, is scheduled to be played in June 2024 in the West Indies and the United States. It will be the first ICC World Cup tournament to feature matches played in the United States. Central Broward Regional Park will be one of the hosts of matches played in the United States. The event is expected to provide national and international exposure for Broward County, bringing numerous
