This item supports the Commission's Value, "Values Differences: Recognizing the value that different perspectives and cultures bring to an organization," and supports the Commission's Goal, "Healthy Community: Cultivating community culture, arts, recreation, and life-long learning." This item also advances the Libraries Division's mission of providing convenient access to a full range of innovative and cost-effective services that satisfy the changing needs of the people of Broward County for information, education, and recreation.

On November 18, 2022, the Urban Libraries Council ("ULC") published its Declaration of Democracy ("Declaration") (Exhibit 2) as a call to action for member libraries to build policies and actions that preserve and protect democracy in their respective communities.
