2	A RESOLUTION OF THE BOARD OF COUNTY
3	COMMISSIONERS OF BROWARD COUNTY, FLORIDA, APPROVING AN AMENDMENT TO THE STATE HOUSING
4	INITIATIVES PARTNERSHIP ("SHIP") LOCAL HOUSING ASSISTANCE PLAN ("LHAP") FOR FISCAL YEARS 2017,
5	2018, AND 2019, TO ADD THÉ CITY OF COCONUT CREEK, FLORIDA ("CITY"), FOR IMPLEMENTATION OF THE
6	CITY'S SHIP PROGRAM FOR FISCAL YEARS 2017, 2018, AND 2019; DIRECTING THE COUNTY ADMINISTRATOR
7	TO SUBMIT THE AMENDED LHAP TO THE FLORIDA HOUSING FINANCE CORPORATION FOR REVIEW AND
8	APPROVAL; AUTHORIZING THE COUNTY ADMINISTRATOR TO EXECUTE ANY NECESSARY
9	DOCUMENTS RELATED TO THE AMENDED LHAP; AUTHORIZING THE COUNTY ADMINISTRATOR TO
10	SUBMIT A REVENUE RESOLUTION TO RECOGNIZE THE TRANSFER OF THE CITY'S SHIP PROGRAM FUNDS TO
11	THE COUNTY; AND PROVIDING FOR SEVERABILITY AND AN EFFECTIVE DATE.
12	
13	WHEREAS, the State of Florida enacted the William E. Sadowski Affordable
14	Housing Act ("Sadowski Act") in 1992 to create a dedicated source of revenue for
15	affordable housing projects using a portion of the documentary stamp taxes from transfers
16	of real estate;
17	WHEREAS, funding for the State Housing Initiatives Partnership ("SHIP") Program
18	was established by the Sadowski Act;
19	WHEREAS, the SHIP Program, codified in Sections 420.907-420.9079,
20	Florida Statutes, and Rule Chapter 67-37, Florida Administrative Code
21	(collectively, the "SHIP Rules and Regulations"), provides funds to local governments as
22	an incentive to create partnerships that produce and preserve affordable homeownership
22	and multifamily housing to serve very low, low, and moderate income families;

WHEREAS, Broward County ("County") is a recipient of SHIP Program funds, and
 as such, is required under Section 420.9075, Florida Statutes, to develop and implement
 a local housing assistance plan ("LHAP") to make affordable housing units available to
 persons of very low, low, and moderate income and to assist persons who have special
 housing needs including the elderly and persons with disabilities;

6 WHEREAS, pursuant to Section 420.9072, Florida Statutes, local governments
7 may enter into interlocal agreements for the purpose of establishing a joint local housing
8 assistance program;

9 WHEREAS, on April 26, 2016 (Agenda Item No. 14), the Broward County Board
10 of County Commissioners ("Board") adopted Resolution No. 2016-243, approving a joint
11 LHAP between the County and the City of Weston ("County's LHAP"), which provided,
12 among other things, for the County to administer the City of Weston's SHIP Program
13 funding allocation within the City of Weston;

WHEREAS, on February 14, 2017 (Agenda Item No. 31), the Board approved an
amendment to the County's LHAP to add the City of Margate to the LHAP and for the
County to administer the City of Margate's SHIP Program funding allocation within the
City of Margate;

WHEREAS, the Board desires to amend the County's LHAP to add the City of
Coconut Creek, and to provide for the County to administer the City of Coconut Creek's
SHIP Program funding allocation for fiscal years 2017, 2018, and 2019, to complete
affordable housing projects within the City of Coconut Creek; and

WHEREAS, pursuant to Section 420.9072, Florida Statutes, and Rule 67-37.006,
Florida Administrative Code, LHAP amendments must be adopted by resolution and

submitted to the Florida Housing Finance Corporation ("Corporation") for review and
 approval, NOW, THEREFORE,

3 BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF4 BROWARD COUNTY, FLORIDA:

5 Section 1. The above recitals set forth in the preamble to this Resolution are
6 true, accurate, and deemed incorporated herein as though set forth in full hereunder.

7 Section 2. The Board approves amending the County's LHAP to add the City of
8 Coconut Creek and to administer the City of Coconut Creek's SHIP Program for State
9 fiscal years 2017, 2018, and 2019.

10 Section 3. The Board authorizes the County Administrator to submit the 11 County's LHAP, amended as provided herein ("Amended LHAP"), to the Corporation for 12 review and approval, and to execute any necessary documents required by the 13 Corporation relating to the Amended LHAP in accordance with the SHIP Rules and 14 Regulations.

Section 4. The Board authorizes the County Administrator to submit to the
Board for adoption a revenue resolution to recognize the SHIP Program funding being
transferred from the City of Coconut Creek to the County for the County's administration
of the City of Coconut Creek's SHIP Program.

19 Section 5 <u>Severability</u>.

If any portion of this Resolution is determined by any court to be invalid, the invalid
portion will be stricken, and such striking will not affect the validity of the remainder of this
Resolution. If any court determines that this Resolution, in whole or in part, cannot be
legally applied to any individual, group, entity, property, or circumstance, such

determination will not affect the applicability of this Resolution to any other individual,
group, entity, property, or circumstance.
Section 6. <u>Effective Date</u> .
This Resolution is effective upon adoption.
