VI. SUMMARY DESCRIPTION:

The Broward Sheriff's Office supports this LETF request for matching funds for the Domestic Violence Program 2021-2022. The Broward Sheriff's Office has been awarded a grant award in the amount of \$300,000.00 from the Department of Children and Families. The purpose of the grant is to fund Salary and Fringe Benefits for two FTE Detectives in the Criminal Investigations Division to work solely on domestic violence cases. There is a required match in the amount of \$100,000.00 for a total program cost of \$400,000.00. The match will be satisfied through a combination of 25% FTE of the supervising Lieutenant (\$42,225.00) leaving a balance of \$57,775.00 from LETF funds.




