The Request for Proposal (RFP) was advertised with a 25% CBE participation goal. Four (4) submittals were received and reviewed. According to the submission requirements for this proposal, in the initial response, bidders must submit a Contractor's Assurance Statement confirming their commitment to the 25% CBE Goal. The Office of Economic and Small Business Development (OESBD) has conducted a review of the proposers' CBE Contractor Assurance Statements. An overview is provided as follows:
