3	COMMISSIONERS OF BROWARD COUNTY, FLORIDA, PERTAINING TO COUNTY COMMISSION MEETINGS AND
4	PROCLAMATIONS; AMENDING SECTIONS 18.5, 18.6, AND 18.46, AND CREATING SECTION 18.47, OF THE
5	BROWARD COUNTY ADMINISTRATIVE CODE ("ADMINISTRATIVE CODE"); AND PROVIDING FOR
6	SEVERABILITY, INCLUSION IN THE ADMINISTRATIVE CODE, AND AN EFFECTIVE DATE.

8	WHEREAS, the Broward County Board of County Commissioners has determined
9	that the rules adopted herein will better ensure orderly, efficient County Commission
10	meetings, NOW, THEREFORE,
11	
12	BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF
13	BROWARD COUNTY, FLORIDA:

15	Section 1. Section 18.5 of the Broward County Administrative Code is hereby
16	amended to read as follows:
17	18.5. Conduct of Meetings; Agenda.

19	e. Ordinances-, Resolutions-, Motions-, and Contracts.

21	2. Approval of Ordinances by County Attorney. All ordinances, resolutions,
22	and contract documents, and any amendments thereto, shall have been
23	reduced to writing and shall have been approved as to form by the County
24	Attorney before presentation to the Commission.

1 3. Introducing for Passage or Approval; Setting for Public Hearing. 2 Ordinances, resolutions, and other matters and subjects requiring action by 3 the Commission, must be introduced and sponsored by a member, or 4 members of the Commission, except that either the County Administrator, 5 the County Auditor, or the County Attorney may present resolutions and 6 other matters or subjects to the Commission for consideration, and any 7 Commissioner may assume sponsorship thereof by moving that such 8 resolution, matter, or subject be adopted in accordance with law; otherwise 9 they shall not be considered. Items setting the public hearing date for 10 ordinances and resolutions shall be included on the consent agenda, unless 11 removed from the consent agenda by a Commissioner.

13 Section 2. Section 18.6 of the Broward County Administrative Code is hereby14 amended to read as follows:

15 **18.6.** Public Participation.

16 Opportunity for Public Comment. Members of the public shall be provided а. 17 a reasonable opportunity to be heard on agenda items before the County Commission, 18 unless otherwise stated in this section or provided by law. Unless otherwise required by 19 law or determined appropriate by the Mayor, a member of the public shall be permitted to 20 comment on any item at only one meeting unless the item substantially and materially 21 changes prior to the County Commission's final consideration of the item or more than 22 thirty (30) days pass between the date public comment occurs and the date the item is 23 subsequently considered by the County Commission.

Section 3. Section 18.46 of the Broward County Administrative Code is hereby
 amended to read as follows:

3 18.46. Authorization of Other Commissioners to Sign on Behalf of County When
4 Mayor and Vice-Mayor are Both Unavailable.

Except as otherwise prohibited by law, and notwithstanding any provision in the
Broward County Administrative Code to the contrary, all contracts and other items other
than ceremonial proclamations that the Mayor or Vice-Mayor is required to sign on behalf
of the County may, if the Mayor and Vice-Mayor are both unavailable, be signed on behalf
of the County by the available sitting Commissioner who most recently served as
County Mayor.

Section 4. Section 18.47 of the Broward County Administrative Code is herebycreated to read as follows:

14 **18.47.** Proclamations.

a. Ceremonial proclamations may only be issued in accordance with the
provisions of this section. Whenever possible, proposed proclamations must be
presented to the Mayor for consideration at least five (5) business days in advance of the
requested date for issuance. Only the Mayor may sign a proclamation on behalf of
Broward County or the Broward County Board of County Commissioners, except as
follows:

 The Vice-Mayor may sign a proclamation timely submitted to the Mayor if the Mayor is unavailable for two (2) consecutive business days and the proclamation is scheduled to be issued prior to the time the Mayor will become available.

2. If the Mayor or Vice-Mayor, as applicable, is unavailable or otherwise unwilling to sign a proclamation, then such proclamation may be issued under the signature of its sponsor(s) if issuance of the proclamation is approved by a majority of the County Commission.

5 b. Copies of all proclamations shall be maintained by the Office of Public6 Communications.

7 c. Any individual permitted to issue a proclamation may either stamp or sign
8 the proclamation or may authorize another person to sign or stamp the proclamation on
9 their behalf.

d. Nothing provided herein shall restrict the ability of an individual
Commissioner to issue certificates of appreciation or similar honors for individuals or
entities, regardless of whether the recipients are within the Commissioner's district, so
long as the applicable honor expressly indicates it is issued in the Commissioner's
individual elected capacity and does not indicate or imply it is issued on behalf of Broward
County or the Board of County Commissioners. A certificate or similar honor issued under
this paragraph may not name a "day" in appreciation of any person or entity.

17 Section 5. <u>Severability</u>.

If any portion of this Administrative Code Resolution is determined by any court to be invalid, the invalid portion will be stricken, and such striking will not affect the validity of the remainder of this Resolution. If any court determines that this Resolution, in whole or in part, cannot be legally applied to any individual, group, entity, property, or circumstance, such determination will not affect the applicability of this Resolution to any other individual, group, entity, property, or circumstance.
