17	awards made by FDOT and the FTA as authorized by Chapter 341, Florida Statutes, and
18	the Federal Transit Administration Act of 1964, as amended; and
19	WHEREAS, the grant requires that the applicant provide a public hearing regarding
20	the application for Section 5310 grant FDOT funding, NOW, THEREFORE,
