RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF BROWARD COUNTY, FLORIDA. SUPPORTING AN APPLICATION FOR A NONMATCHING \$199,998 GRANT TO THE FLORIDA FISH AND WILDLIFE CONSERVATION COMMISSION **FLORIDA** IMPROVEMENT PROGRAM; AUTHORIZING THE COUNTY ADMINISTRATOR TO TAKÉ ALL ACTIONS NECESSARY SAME; **IMPLEMENT** AND PROVIDING SEVERABILITY AND AN EFFECTIVE DATE.

WHEREAS, the Parks and Recreation Division has requested authorization to submit a grant application to the Florida Fish and Wildlife Conservation Commission ("FWC") Florida Boating Improvement Program ("FBIP") for a nonmatching grant in the amount of One Hundred Ninety-nine Thousand Nine Hundred Nighty-eight Dollars (\$199,998) (the "Grant") to be used on a project entitled Hollywood North Beach Park Mooring Fields, in Hollywood, Florida (the "Project"); and

WHEREAS, the Project will provide for the construction and installation of recreational vessel mooring fields, a floating dinghy dock, and the expansion of an existing restroom to provide shower facilities to the transient boaters tied up to a mooring ball in the mooring fields, NOW, THEREFORE,

BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF BROWARD COUNTY, FLORIDA:

Section 1. The Board hereby authorizes the Director of the Parks and Recreation Division, Dan West, to submit an application for the Grant. The Board also authorizes Jay Sanford to serve as the County's official representative in connection with the application for the Grant, and if awarded, to administer the Grant on behalf of the County.
