RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF BROWARD COUNTY FLORIDA. AUTHORIZING THE FILING OF AN AMENDED APPLICATION FOR FEDERAL ASSISTANCE FOR FEDERAL FISCAL YEAR 2020 WITH THE FEDERAL TRANSIT ADMINISTRATION (FTA) PURSUANT TO 49 U.S.C. SECTION 5339, BUS AND BUS FACILITIES FORMULA GRANTS, INCREASING IT BY FORTY NINE THOUSAND NINETY-SEVÉN DOLLARS (\$49,097) FOR A NEW TOTAL AMOUNT UP TO THREE MILLION FIVE HUNDRED EIGHT-ONE THOUSAND NINETY-ONE DOLLARS **UNDER** (\$3,581,091) THE **FEDERAL** TRANSIT AUTHORIZÍNG THE DIRECTOR OF THE TRANSPORTATON WITH DEPARTMENT **FURNISH** FTA TO ADDITIONAL INFORMATION WHICH MAY BE REQUIRED; AUTHORIZING THE COUNTY ADMINISTRATOR TO TAKE ANY NECESSARY ADMINISTRATIVE OR BUDGETARY ACTIONS TO ACCEPT THE GRANT FUNDING: AND PROVIDING FOR EFFECTIVE DATE.

WHEREAS, several municipalities were awarded Federal Transit Administration (FTA) Urbanized Area Formula Funds and Bus and Facilities Formula Grant funds for fiscal years 2016, 2017, and 2018;

WHEREAS, those municipalities have requested that Broward County accept the funds previously allocated, and use the funds to supplement capital investments; and

WHEREAS, it is required by the U.S. Department of Transportation, in accordance with the provisions of Title VI of the Civil Rights Act of 1964, that in

connection with the filing of an application for assistance under the Federal Transit Act, 2 as amended, the applicant give an assurance that it will comply with Title VI of the Civil 3 Rights Act of 1964, and applicable requirements of the U.S. Department of Transportation, NOW, THEREFORE, 4 5 BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF 6 7 BROWARD COUNTY, FLORIDA: 8 9 Section 1.
