10	Department of Transportation ("FDOT") provides technical and financial assistance for
11	intercity bus service;
12	WHEREAS, FDOT has approved One Hundred Eighty-two Thousand
13	Eighty-eight Dollars (\$182,088) in Fiscal Year 2021 capital funding for the leased park
14	and ride facility associated with operating the Interstate 95 Express Bus Service; and
15	WHEREAS, a Public Transportation Grant Agreement must be approved by the
16	transit agency's governing body, NOW, THEREFORE,

18	BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF
19	BROWARD COUNTY, FLORIDA:

21	Section 1. The Board of County Commissioners of Broward County, Florida
22	(the "Board"), hereby approves and authorizes the Mayor to execute the Public
23	Transportation Grant Agreement (PTGA) with FDOT, District 4, in substantially the form
24	attached as Exhibit 1, in the amount of One Hundred Eighty-two Thousand Eighty-eight

1	Dollars (\$182,088) granted under Financial Project No. 442692-1-94-01, to provide
2	capital funding for the leased park and ride facility associated with the Interstate 95
3	Express Bus Service.
4	Section 2. The Board authorizes the County Administrator to take all
5	necessary administrative and budgetary actions to implement the PTGA.
