

1 RESOLUTION NO. 2020-

2 A RESOLUTION OF THE BOARD OF COUNTY
3 COMMISSIONERS OF BROWARD COUNTY, FLORIDA,
4 ADOPTING THE BROWARD COUNTY TRANSIT
5 DEVELOPMENT PLAN 2021-2030 ANNUAL UPDATE; AND
6 PROVIDING FOR AN EFFECTIVE DATE.

7 WHEREAS, Section 341.052, Florida Statutes, created the public transit block
8 grant program administered by the Florida Department of Transportation (FDOT);

9 WHEREAS, Broward County is a recipient of FDOT public transit block grant
10 funds;

11 WHEREAS, Rule 14-73.001, Florida Administrative Code (F.A.C.), titled "Public
12 Transit," sets forth FDOT's requirements for recipients of public transit block grant funds;

13 WHEREAS, pursuant to Rule 13-73.001, F.A.C., Broward County is required to
14 prepare Transit Development Plans (TDPs) as its planning, development, and operational
15 guidance documents, based on a ten (10) year planning horizon;

16 WHEREAS, Broward County is required to submit annual TDP updates to FDOT
17 in the form of progress reports documenting, among other things, the past year's
18 accomplishments, analysis of any discrepancies between the plan and its implementation
19 for the past year and steps that will be taken to attain original goals and objectives,
20 revisions to the implementation program for the coming year, added recommendations,
21 a revised financial plan, and a revised list of projects or services needed to meet the goals
22 and objectives;

23 WHEREAS, Broward County Transportation Department, Transit Division, has
24 developed the Broward County Transit Development Plan 2021-2030 Annual Update,
which, if approved by FDOT, will provide an estimated Ten Million Eight Hundred

1 Fifty-eight Thousand Five Hundred Twenty-two Dollars (\$10,858,522) in FDOT Fiscal
2 Year 2022 public transit block grant funds for Broward County Transit operations and
3 maintenance expenses; and

4 WHEREAS, TDPs must be approved by the Board of County Commissioners of
5 Broward County, Florida, NOW, THEREFORE,

7 BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF
8 BROWARD COUNTY, FLORIDA:

10 Section 1. The Board of County Commissioners hereby adopts the Broward
11 County Transit Development Plan 2021-2030 Annual Update, a copy of which is attached
12 hereto and incorporated herein by reference as if set forth in full.
