I. REQUEST: Provide a description of the features of the product/service or Scope of Work.

The growing demand for, and insufficient access to, affordable housing continues to be a top priority for the Board of County Commissioners. The Broward Housing Council, an advisory Board to the County Commission, has sponsored an Affordable Housing Needs Assessment and subsequent updates for Broward County since 2009. Due to the release of recent 2020 US Census data, many of the Study's key findings and assumptions are outdated, including housing supply and demand projections, employment growth by industries, and cost-burdened households. In order to enable the members of the Broward Housing Council and other affordable housing policymakers to base key decisions on current market dynamics, it is important to update the Study once again. As in previous updates, the 2021 Study will provide a current perspective on the local economy and housing needs throughout Broward County, and an assessment on the key supply and demand factors impacting the production and how they have changed since the 2018 update. It will also discuss availability of affordable housing and assess the progress in addressing the existing and future demand on affordable and workforce housing based on new socio-economic data.

The Metropolitan Center at Florida International University (MC/FIU) is an applied research and training institute that provides policy solutions to the private and public sectors. The MC/FIU team is led by Dr. Ned Murray, Associate Director, AICP, who has proven experience with Broward County housing studies and models, and was responsible for the initial Study and all subsequent updates since 2009. MC/FIU also has access to proprietary data sources which are layered on traditional census and local housing market data, to provide a comprehensive analysis of affordable housing demand and supply. In fact, the housing supply methodology used by MC/FIU was recently adopted as the County's preferred methodology per BCLUP PCT

The County Commission recently adopted MC/FIU's methodology (PCT 20-2) as the preferred methodology for calculating affordable housing supply. This means that Municipalities and the Broward County Planning Council are required to use this study to evaluate housing affordability to
