SECOND AMENDMENT TO THE AGREEMENT BETWEEN BROWARD COUNTY AND LEO A DALY COMPANY FOR CONSULTANT SERVICES FOR BROWARD COUNTY'S MEDICAL EXAMINER'S OFFICE AND BSO'S CRIME LAB COMBINED FACILITY (RFP # S2115731P1)

This Second Amendment ("Second Amendment"), to the February 7, 2019, Agreement between Broward County, a political subdivision of the State of Florida ("County"), and Leo A Daly Company, a Nebraska corporation having an office at 1400 Centrepark Boulevard, Suite 500, West Palm Beach, FL 33401 ("Consultant") (collectively referred to as the "Parties"), is entered into and effective as of the date this Second Amendment is fully executed by the Parties (the "Effective Date").

RECITALS

- A. On February 7, 2019, the Parties entered into an Agreement for Consultant Services for Broward County's Medical Examiner's Office and BSO's Crime Lab Combined Facility ("Agreement").
- B. The Parties desire to amend the Agreement to update Attachment 1: Project Schedule to extend the timeframe of Consultant's Document Preparation and Submittal for the 50% Construction Document Phase from forty-two (42) calendar days to eighty-four (84) calendar days at no additional cost to the County and to update Section 4.3 of the Agreement.

Now, therefore, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties agree as follows:

- 1. The above Recitals are true and correct and are incorporated herein by reference.
- 2. First Amendment Attachment 1: Project Schedule attached to Exhibit A: Project Schedule of the Agreement is hereby replaced with Attachment 1: Project Schedule, attached to this Second Amendment.
- 3. Section 4.3 of the Agreement is hereby amended as follows:
 - 4.3 If the Contract Administrator determines that In the event Consultant is unable to complete the above services within the time periods specified in Attachment 1: Project Schedule because of delays resulting from untimely review by County or other governmental authorities having jurisdiction over the Project, and such delays are not the fault of Consultant, or because of delays which were caused by factors outside the control of Consultant, County the Contract Administrator shall grant a reasonable extension of time for completion of the services and shall provide reasonable compensation, if appropriate. It shall be the responsibility of Consultant to notify the Contract Administrator promptly in writing whenever a delay in approval by a governmental agency is anticipated or experienced, and whenever a delay has been caused by factors

<u>outside of Consultant's control</u>, and to inform the Contract Administrator of all facts and details related to the delay. <u>Consultant must provide such written notice to the Contract Administrator within three (3) business days after the occurrence of the event causing the <u>delay</u>.</u>

- 4. Except as set forth in this Second Amendment, all other terms, conditions, and covenants contained in the Agreement between the Parties, as previously amended, shall remain in full force.
- 5. In the event of any conflict or ambiguity between this Second Amendment and the Agreement, as previously amended, the parties agree that this Second Amendment shall control.
- 6. All capitalized terms not identified in this Second Amendment shall have the same meanings as the defined terms found in the Agreement, as previously amended. Amendments are indicated by the use of underlining to indicate additions and strikethrough to indicate deletions.
