#### SCOPE OF SERVICES

I. The following task replaces the existing TASK 8 in Exhibit A to WA WZA-2.27:

#### TASK 8 LIMITED CONSTRUCTION ADMINISTRATION ASSISTANCE

During the construction phase of the project, Consultant shall provide Limited Construction Administration Services for the County and awarded contractor on an as-needed basis. Consultant will provide RFI, request for information review. Limited Construction Administration Services shall include monthly on-site meetings with the general contractor, the subcontractors, and owner's representative. Consultant will review the construction when requested, review and approve payment applications, review change order requests, review actual progress with construction schedule. Limited Construction Administration Services are based on an hourly allowance of 116 combined hours for the construction duration.
