Subject: Ordinance No. 2020-an Ordinance of The Board of County Commissioners Of Broward County, Florida, Pertaining to The Broward County Bidding Preference For Local Vendors; Amending Sections 1-74 And 1-75 Of the Broward County Code Of Ordinances ("Code"); Providing For Inclusion Of Principal Place Of Business In The Evaluation Criteria For Certain Procurements; And Providing For Severability Inclusion in the Code, And an Effective Date.

Dear Mayor Holness:

County Attorneys, Renee Harrod and Tricia Brissett, briefed the Broward County Small Business Development Advisory Board, at its January 20, 2020 meeting, on a draft of the proposed amendment to the Local Bidding Preference Ordinance.

Subsequently, the Broward County Small Business Development Advisory Board unanimously passed a motion authorizing me to draft and sign this letter to the Board of County Commissioners, after the Ordinance has been placed on the agenda, stating that “the Advisory Board is providing its feedback to ensure that the amendment to the Local Bidding Preference Ordinance strengthens the existing Ordinance.” While several members of our board myself included were of the original opinion that “if it's not broke then don't fix it” we were further assured by the County Attorney's office and Director of OESBD that this amendment to the ordinance would only further strengthen the bidding preference for local Broward County vendors. Based on our briefing from Attorney's Harrod and Brissett, and after reviewing the proposed amendment to the ordinance, it is our opinion that this amendment indeed strengthens the ordinance.

In conclusion, Broward County Small Business Development Advisory Board, at its January 8th meeting, asked Deputy County Attorney Harrod to forward the proposed document to the
