1	Section 1. The Board of County Commissioners of Broward County, Florida
2	(the "Board"), hereby approves and authorizes the Mayor to execute a PTGA with
3	FDOT, in substantially the form attached as Exhibit 1, in the amount of One Million Four
4	Hundred Thousand Dollars (\$1,400,000) granted under Financial Project No. 424219-4-
5	84-01, to provide funding for the operation and maintenance of Interstate 95 Express
6	Bus Service.
7	Section 2. The Board authorizes the County Administrator to take all
8	necessary administrative and budgetary actions to implement the PTGA.
9	Section 3. <u>Effective Date</u> .
