The Office of Economic and Small Business Development (OESBD) has evaluated Hazen and Sawyer PC's CBE participation for the North Regional Wastewater Treatment Plant-Capacity Improvements as of June 19, 2020. This contract was awarded to Hazen and Sawyer, PC on August 13, 2013 and the First Amendment was issued on January 7, 2016. The intent of the proposed amendment is to provide permitting assistance for regulatory and additional engineering services for the injection wells if needed. This review is based on information provided by the requesting agency and the prime consultant, Hazen and Sawyer, PC. The CBE Goal for the overall agreement is 25% and Hazen and Sawyer PC's CBE commitment is 25%. An overview is provided as follows:
