2 A RESOLUTION OF THE BOARD OF COUNTY
3 COMMISSIONERS OF BROWARD COUNTY, FLORIDA,
4 AUTHORIZING AN APPROPRIATION AND
5 DISBURSEMENT OF FUNDS IN THE AMOUNT OF
6 \$1,551,086 TO CONTRIBUTE TO LOCAL MATCH FUNDING
7 FOR SPECIFIED SERVICE PROVIDERS FOR THE STATE
8 OF FLORIDA FISCAL YEAR 2019-2020; AUTHORIZING
9 THE COUNTY ADMINISTRATOR TO EXECUTE THE
10 AGREEMENTS WITH THE SERVICE PROVIDERS AND TO
11 TAKE ALL NECESSARY ADMINISTRATIVE AND
12 BUDGETARY ACTIONS TO IMPLEMENT THE
13 AGREEMENTS; AND PROVIDING FOR SEVERABILITY
14 AND AN EFFECTIVE DATE.

15 WHEREAS, the Board of County Commissioners of Broward County, Florida
16 (“Board”), provides funding each year as a local match contribution to community-based
17 mental health and substance abuse treatment service providers (“Service Providers”)
18 based on the State of Florida Department of Children and Families (“DCF”) statutory
19 matching requirements provided in Section 394.76, Florida Statutes;

20 WHEREAS, DCF has designated Broward Behavioral Health Coalition, Inc.
21 (“BBHC”), as the managing entity for coordinating community-based mental health and
22 substance abuse treatment services in Broward County through various Service
23 Providers;

24 WHEREAS, DCF has allocated funds from its Fiscal Year 2019-2020 budget for
community-based adult mental health and substance abuse treatment services
coordinated by BBHC in Broward County;

WHEREAS, the Board desires to base Broward County’s local match contributions
on the amounts allocated to BBHC for adult mental health and substance abuse treatment
services;

1 WHEREAS, the Board desires to authorize the Broward County Administrator
2 (“County Administrator”) to execute the individual agreements with the specified Service
3 Providers on behalf of Broward County; and

4 WHEREAS, the Board finds that programs providing mental health and substance
5 abuse treatment services serve a public purpose, NOW, THEREFORE,

7 BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF
8 BROWARD COUNTY, FLORIDA:

10 Section 1. Authorized Appropriation and Disbursement.

11 The Board hereby authorizes an appropriation and disbursement of funds for
12 Fiscal Year 2019-2020 for the Service Providers as set forth in Attachment A.

13 Section 2. Execution of Agreements by the County Administrator.

14 The County Administrator is hereby authorized to execute the local matching funds
15 agreement (using the previously approved local matching funds standard form
16 agreement) with each of the Service Providers listed in Attachment A, to amend these
17 agreements as authorized, and to take all necessary administrative and budgetary actions
18 to implement the agreements. Authorized amendments include those necessary to
19 reallocate monies among the Service Providers listed in Attachment A when it is in the
20 best interest of Broward County or as may be required to comply with statutory matching
21 requirements, except that the total allocation to all Service Providers must not exceed the
22 amount appropriated under this Resolution. Nothing in this Resolution will be construed
23 to alter the requirement that the agreements be approved by the Office of the County

1 Attorney for legal sufficiency before execution. Any material deviations from the approved
2 local matching funds agreement must be presented to the Board for approval.

3 Section 3. Severability.

4 If any portion of this Resolution is determined by any court to be invalid, the invalid
5 portion will be stricken, and such striking will not affect the validity of the remainder of this
6 Resolution. If any court determines that this Resolution, in whole or in part, cannot be
7 legally applied to any individual, group, entity, property, or circumstance, such
8 determination will not affect the applicability of this Resolution to any other individual,
9 group, entity, property, or circumstance.

10 Section 4. Effective Date.

11 This Resolution is effective upon adoption.
