## Re: Operating Agreement for Transportation Network Company Services at Fort Lauderdale-Hollywood International Airport and Port Everglades between Broward County and Vibe Direct, LLC d/b/a Vibe Rides

Dear Ms. Olivito:

This letter is to notify you that the Broward County Aviation Department ("BCAD") will be requesting the Board of County Commissioners ("Board") for approval to terminate the Operating Agreement for Transportation Network Company Services at Fort Lauderdale-Hollywood International Airport and Port Everglades between Broward County ("County") and Vibe Direct, LLC d/b/a Vibe Rides ("Vibe"), dated December 8, 2020 ("Agreement").

In accordance with Section 5.1 of the Agreement, the Agreement may be terminated for cause by the aggrieved party if the party in breach has not corrected the breach within ten (10) days after receipt of written notice from the aggrieved party identifying the breach. BCAD sent a Notice of Breach to Vibe, dated February 3, 2021, stating that the County had not yet received the required Security Deposit, Report, and Fees. BCAD asked Vibe to cure the breach by submitting the Security Deposit, Report, and Fees by Monday, February 15, 2021.

Additionally, due to wintry weather that crossed much of the United States resulting in a declaration of a state of emergency in Texas, the County provided an extension to cure the breach and requested that Vibe submit the Security Deposit, Report, and Fees by March 22, 2021.

As of April 26, 2021, the County has not yet received the required security deposit for the Airport and the Port. The Port has not yet received any of Vibe's Company Reports and the Airport has not yet received Vibe's December 2020 Company Report. Additionally, Vibe has not yet established the Geofence for the Port as required in the Agreement.

Vibe has represented that it has not provided any TNC Services to the Airport or Port. BCAD will be requesting the Board to authorize the Director of Aviation to terminate the Agreement for cause. Vibe has not yet met the terms of the Agreement; however, Vibe will not be prohibited from applying for a new agreement with the County at a future date.
