### CASH BOND(S)

This is an agreement, made and entered into by and between: BROWARD COUNTY ("COUNTY"), a political subdivision of the state of Florida,

### AND

<u>COOPER SQUARE 26 LLC</u>, a Florida limited liability company, and its successors and assigns ("DEVELOPER").

## WITNESSETH

WHEREAS, COUNTY, by and through its Environmental Protection and Growth Management Department ("Department"), shall or has issued License No. <u>DF17-1230</u> ("License"), to DEVELOPER; and

WHEREAS, one of the conditions of approval of the License was bonding by DEVELOPER for compliance with certain construction, monitoring and maintenance ("Construction, Monitoring and Maintenance") of mitigation areas required to be installed or enhanced pursuant to the License; and

WHEREAS, DEVELOPER desires to provide to the COUNTY a Cash Bond, payable to the Broward County Board of County Commissioners, as replacement Surety to secure the Construction, Monitoring and Maintenance; NOW, THEREFORE,

In consideration of the mutual terms, conditions, promises, covenants, and payments hereinafter set forth, COUNTY and DEVELOPER agree as follows:

1. DEVELOPER shall bond for the actual Construction, Monitoring and Maintenance requirements set forth in the License.

- 2. DEVELOPER is responsible for carrying out the actual Construction, Monitoring and Maintenance requirements as set forth in the license.
- 3. The estimated costs of the improvements are, for Construction, <u>Seventy-</u> <u>Five Thousand Five Hundred</u> Dollars (<u>\$75,500.00</u>) and, for Monitoring and Maintenance, <u>Twenty-Eight Thousand</u> Dollars (<u>\$28,000.00</u>).
- 4. The Construction, Monitoring and Maintenance requirements shall be secured by cash, check (cashier's, certified, or registered), or money order issued by Ocean Bank (financial institution), a copy of which is attached hereto as Exhibit "A", in the amount of <u>One Hundred Three Thousand, Five Hundred Dollars (\$103,500.00</u>), payable to the Broward County Board of County Commissioners. The DEVELOPER may, at its option, later provide to the COUNTY a surety bond or letter of credit in like amount acceptable to COUNTY to be substituted for the cash, check, or money order.
- 5. If the DEVELOPER should fail to carry out the Construction, Monitoring or Maintenance required, the COUNTY may, in addition to all other remedies available at law and equity, draw upon the Cash Bond and use the funds for Construction, Monitoring or Maintenance required by the License.
- 6. Upon completion of the Construction, the DEVELOPER shall notify the Department of such completion and, upon a determination in writing to DEVELOPER by the Department that the Construction required by the License has been completed, the COUNTY shall have ninety (90) days from the date of such determination to remit <u>Seventy-Five Thousand Five Hundred</u> Dollars (<u>\$75,500.00</u>) to the DEVELOPER, provided that the COUNTY has not already effected a remittance to the DEVELOPER because of the earlier substitution of a surety bond or a letter of credit.
- 7. Upon completion of the Monitoring and Maintenance, the DEVELOPER shall notify the Department of such completion and, upon a determination in writing to DEVELOPER by the Department that the Monitoring and Maintenance required by the License has been completed, the COUNTY shall have ninety (90) days from the date of such determination to remit \_ <u>Twenty-Eight Thousand</u> Dollars (\$28,000.00) to the DEVELOPER, provided that the COUNTY has not already effected a remittance to the DEVELOPER because of the earlier substitution of a surety bond or a letter of credit.
- 8. Remittance to DEVELOPER of any contingency fee required to be paid will be done in accordance with the License.
