WHEREAS, the Broward County Board of County Commissioners ("Board") desires to submit to the State of Florida, Department of Health ("DOH"), Bureau of Emergency Medical Services, Broward County's Emergency Medical Services ("EMS") County Grant Application 2022-2023 ("Application") for EMS County Grant funds in the amount of Eighty-seven Thousand One Hundred Sixty Dollars (\$87,160);

WHEREAS, the Board certifies that the EMS County Grant funds will be used to improve and expand prehospital EMS in Broward County, and will not be used to supplant existing County budget allocations for EMS; and

22 WHEREAS, the Board desires to approve the EMS County Grant Program funding 23 distribution, subject to approval of the Application by the DOH, NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF 24 25 BROWARD COUNTY, FLORIDA: 26 Section 1. The Board adopts and affirms the foregoing recitals. 27 Section 2. The Board authorizes the County Administrator to execute and 28 submit the Application to the DOH for EMS County Grant funds in the amount of 29 Eighty-seven Thousand One Hundred Sixty Dollars (\$87,160). 30 Section 3. The County certifies that the EMS County Grant funds will improve 31 and expand the County's prehospital emergency medical system and will not be used to 32 supplant existing County budget allocations for EMS. 33 Section 4. The County approves the distribution of the EMS County Grant funds 34 as set forth in Attachment A hereto. 35 Section 5. Upon approval of the Application by the DOH, the County 36 Administrator is authorized to execute agreements and amendments relating to the EMS 37 County Grant funds, subject to review as to legal sufficiency by the Office of the County 38 Attorney, for the projects described in Attachment B hereto, including amendments 39 revising project leaders, extending the term, or increasing the funding amount by utilizing 40 unexpended EMS County Grant Funds allocated for FY 2023 projects. 41 Section 6.
