2 A RESOLUTION OF THE BOARD OF COUNTY
3 COMMISSIONERS OF BROWARD COUNTY, FLORIDA,
4 ACCEPTING AN EASEMENT RELATED TO THE PROVISION
5 OF WATER AND WASTEWATER SERVICES, IN, OVER,
6 UNDER, THROUGH, UPON, AND ACROSS A PORTION OF
7 REAL PROPERTY LOCATED IN THE CITY OF POMPANO
8 BEACH, FLORIDA; AND PROVIDING FOR SEVERABILITY
9 AND AN EFFECTIVE DATE.

10 WHEREAS, City of Pompano Beach (“Grantor”) is the owner of certain property in
11 the City of Pompano Beach (“Property”), which Property is more particularly described in
12 the legal description and sketch made subject to the Easement agreement in Attachment
13 1;

14 WHEREAS, Broward County (“County”) requested from Grantor an unrestricted
15 and perpetual non-exclusive easement, in, over, under, through, upon, and across a
16 portion of the Property to construct, maintain, repair, install, and rebuild thereon water
17 mains, wastewater gravity mains, wastewater force mains, reclaimed water mains, and/or
18 any other water and wastewater facilities, for purposes of providing water supply service
19 for domestic uses and collecting domestic or other kinds of wastewater to and from the
20 Property (“Easement”);

21 WHEREAS, Grantor is willing to grant an Easement to the County as provided in
22 the Easement agreement in Attachment 1; and

1 WHEREAS, the Board of County Commissioners of Broward County, Florida
2 (“Board”), has determined that acceptance of the Easement agreement serves a public
3 purpose and is in the best interest of the County, NOW, THEREFORE,

5 BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF
6 BROWARD COUNTY, FLORIDA:

8 Section 1. The recitals set forth in the preamble to this Resolution are true,
9 accurate, and incorporated by reference herein as though set forth in full hereunder.

11 Section 2. The Board hereby accepts the Easement agreement attached to this
12 Resolution as Attachment 1.

14 Section 3. The Easement agreement in Attachment 1 shall be properly
15 recorded in the Public Records of Broward County, Florida.
16

17 Section 4. Severability.

18 If any portion of this Resolution is determined by any court to be invalid, the invalid
19 portion will be stricken, and such striking will not affect the validity of the remainder of this
20 Resolution. If any court determines that this Resolution, in whole or in part, cannot be
21 legally applied to any individual, group, entity, property, or circumstance, such
22 determination will not affect the applicability of this Resolution to any other individual,
23 group, entity, property, or circumstance.
