RESOLUTION OF THE **BOARD** OF COUNTY COMMISSIONERS OF **BROWARD** COUNTY. FLORIDA. ACCEPTING AN EASEMENT RELATED TO THE PROVISION AND WASTEWATER WATER SERVICES, ACROSS, UNDER, AND THROUGH A PORTION OF REAL PROPERTY LOCATED IN THE CITY OF LAUDERDALE LAKES, FLORIDA; AND PROVIDING FOR SEVERABILITY AND AN EFFECTIVE DATE.

WHEREAS, BV Apartments, LLLP ("Grantor"), is the owner of certain property located in the City of Lauderdale Lakes, Florida ("Property"), which Property is more particularly described in the legal description and sketch made subject to the Easement agreement in Attachment 1;

The recitals set forth in the preamble to this Resolution are true, accurate, and incorporated by reference herein as though set forth in full hereunder. 10 11 Section 2. The Board hereby accepts the Easement agreement attached to 12 this Resolution as Attachment 1. 13 14 Section 3. The Easement agreement in Attachment 1 shall be properly 15 recorded in the Public Records of Broward County, Florida. 16 17 Section 4. Severability. 18 If any portion of this Resolution is determined by any court to be invalid, the 19 invalid portion will be stricken, and such striking will not affect the validity of the 20 remainder of this Resolution. If any court determines that this Resolution, in whole or in 21 part, cannot be legally applied to any individual, group, entity, property, or circumstance, 22 such determination will not affect the applicability of this Resolution to any other 23 individual, group, entity, property, or circumstance. 24
