RESOLUTION NO. 2020-

RESOLUTION OF THE BOARD OF COUNTY OF BROWARD COUNTY. COMMISSIONERS PROVIDING FOR A REFERENDUM ELECTION HELD ON NOVEMBER 3, 2020, THE DATE GENERAL ELECTION. TO DETERMINE WHETHER AMEND THE **BROWARD** COUNTY CHARTER EXPRESSLY ALLOW REGIONAL PARKS IN BROWARD TO BE USED FOR PUBLIC HEALTH AND PURPOSES DURING EMERGENCIES; PROVIDING FOR SEVERABILITY AND AN EFFECTIVE DATE.

WHEREAS, Broward County ("County") invests more than \$40 million annually in the maintenance and operation of thousands of acres of parks, and welcomes millions of visitors to County parks every year;

WHEREAS, under a 2011 amendment to the County Charter ("Charter"), County Regional Parks may be used only for outdoor leisure, athletic, or recreational activities;

WHEREAS, although the County is committed to preserving County Regional Parks for leisure, athletic, and recreational activities, certain public health or safety circumstances, such as the ongoing worldwide pandemic of COVID-19, were not anticipated in 2011 and were therefore not considered when limiting the permitted uses of the Regional Parks;

WHEREAS, some County Regional Parks are optimal locations to serve critical public health and safety needs in an urban county like Broward, such as conducting medical testing, food distribution, and logistical staging during the COVID-19 pandemic or in connection with hurricanes;

WHEREAS, natural disasters such as hurricanes and public safety emergencies present unpredictable risks for every community in the County, and public health and

safety would be enhanced by the County being able to use its Regional Parks in response 2 to such emergencies; 3 WHEREAS, Section 2.06 of the Charter authorizes the Broward County Board of County Commissioners ("Board") to propose amendments and revisions to the Charter, 4 5 subject to a referendum of the general electorate; 6 WHEREAS, the Board desires to place an amendment to the Charter before the 7 voters at the November 3, 2020, General Election; and 8 WHEREAS, using Regional Parks for public health and safety purposes during a declared state of emergency would not materially disrupt the public's use and enjoyment of the parks but would provide a countywide benefit to the County's residents, NOW, 10 11 THEREFORE. 12 13 BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF 14 BROWARD COUNTY, FLORIDA: 15 Section 1. Subject to an affirmative vote of the general electorate, Section 8.13 16 of the Charter of Broward County, Florida, titled Broward County park preservation, is 17 hereby amended to read as follows: 18 Section 8.13. 18	Section 2. A referendum election is called for the General Election on
19	November 3, 2020, and at such other times as permitted for voting under Chapter 101,
20	Florida Statutes, to determine whether the Charter should be amended to expressly
21	permit utilization of County Regional Parks for Public Health and Safety Purposes.
22	Section 3. In accordance with Section 100.342, Florida Statutes, at least thirty
23	(30) days' notice of the referendum election shall be published by the Broward County
24	Administrator in a newspaper of general circulation in Broward County. The publication

shall be made at least twice, including once in the fifth week and once in the third week prior to the week in which the referendum is to be held. The notice is hereby attached as Exhibit A and made a part hereof.

Section 4. Said referendum election shall be held between the hours of 7:00 a.m. and 7:00 p.m. on Tuesday, November 3, 2020, and at such other days and times as provided under applicable law, including early voting as provided by Section 101.657, Florida Statutes, at polling places established in Broward County. All registered and qualified electors in Broward County shall be eligible to vote in the referendum election. Vote-by-mail ballots and early voting access for the referendum shall be made available as provided by law.

Section 5. The election boards consisting of the clerks and inspectors appointed to serve for the General Election on November 3, 2020, are hereby appointed to serve in the referendum election in the manner provided by law.

Section 6. The Broward County Canvassing Board shall canvass the returns in said election and shall certify the results of the referendum election as provided by law.

Section 7. The County Administrator shall timely furnish a certified copy of this adopted Resolution to the Supervisor of Elections for Broward County.

Section 8. The title and summary of the referendum question to appear on the General Election ballot on November 3, 2020, as embodied in this enabling Resolution, shall be as follows:

If any court determines that this Resolution, in whole or in part, cannot be legally applied to any individual, group, entity, property, or circumstance, such determination will not affect the applicability of this Resolution to any other individual, group, entity, property, or circumstance. If the County determines any part of the ballot statement, including the fiscal impact statement, is contrary to state law, the County Attorney is authorized to request that the Supervisor of Elections remove the applicable

NOTICE OF REFERENDUM ELECTION TO BE HELD ON TUESDAY, NOVEMBER 3, 2020, AND AT SUCH OTHER TIMES AS PROVIDED FOR EARLY VOTING BY SECTION 101.657, FLORIDA STATUTES, TO DETERMINE WHETHER TO AMEND THE BROWARD COUNTY CHARTER TO EXPRESSLY ALLOW REGIONAL PARKS IN BROWARD COUNTY TO BE USED FOR PUBLIC HEALTH AND SAFETY PURPOSES DURING EMERGENCIES.
