

VI. SUMMARY DESCRIPTION:

The Men of Tomorrow program was created to promote the development and success of young African American men by emphasizing the importance of high school and college graduation, given that school completion is the single best predictor of future economic success. This program affords these mentees the opportunity to participate in several critical youth developmental activities including organized program workshop sessions addressing various topics related to college preparation, social development, responsible decision making, and financial literacy. In addition, other activities offered to promote development (and foster participation to otherwise inaccessible opportunities for some young men) include: 1) guided college tours to inspire and prepare the participants for upper level education; 2) participation in Project Alpha, a workshop designed to provide education, motivation and skill-building on issues of responsibility, substance abuse, relationships, teen pregnancy and sexually transmitted diseases for young males ages 12-17 years; and 3) participation in activities such as oratorical competitions, attendance at sporting events, and local communities events; and 4) the promotion of emotional, physical, and mental health.





VI. SUMMARY DESCRIPTION:

The Respite program is a much-needed new program to provide the families of children/young adults with special needs a supportive and nurturing Respite experience. Additionally, 13% of the population in Broward has a disability. This includes thousands of children who are at risk for abuse and neglect by their caregivers. The program aims to give parents/caregivers time off and temporarily relieve the stress they experience while providing extra care to a child/young adult with special needs. Many of their families have children with multiple disabilities and other siblings with disabilities. They serve children and adults in single-parent households as well as children cared for by extended family members. Approximately 80% of the families served earn an income below the federal poverty level, experience innumerable other hardships and are simply unable to afford care for their children. The strain can have a wide range of negative effects on healthy family life and living and can also likely impede developmental, emotional, behavioral, and intellectual progress for the child/young adult in need. Respite care aims to combat and diminish those negative impacts.







VI. SUMMARY DESCRIPTION:

The iMfit2SUCCEED Program is designed for at-risk youth age 13+ who have been exposed to, and/or suffered from abuse, neglect, rejection, and abandonment and have been placed in out-of-home care and shelters. It is a prevention and prep program that: 1.) improves their overall wellness by providing healing of the mind, body, and spirit; 2) trains them to be self-sufficient; 3) and educates them with the academics, skills, and professional development they need to succeed. Through dependable mentorships and small-group time, the teens can expect to enjoy a curriculum that includes, but is not limited to, self-care, disease prevention, physical activity, sports, the arts, nutrition, healthy meal and snack preparation, money management, non-violent conflict resolution, managing an apartment or shared space, saving and investing their money, writing their resume, interviewing, learning professional acumen in real-life business settings, gain experience by serving on a committee, leading a team, and communicating professionally. Personal incentives will be built into each individual's success plan to prevent program attrition, and certificates will be awarded for completion. Although the program was written a few years ago, this will be the first opportunity to deliver it as intended, as Big Children's Foundation will be opening a boutique Education Center in Oakland Park in the Fall 2022 which will allow for the full-scale delivery of their iMfit2SUCCEED Program.

Female Development World Organization believes not enough emphasis is placed on prevention of two of the most long-term traumatic experiences plaguing our communities: child sexual abuse and human trafficking. These traumatic effects create root causes of illegal substance use and incarceration as children becomes adults. The program, aimed at diverting youths from the criminal justice system, will educate 40 youth (ages 8-14) about danger signs of human trafficking, child sexual abuse and its relation to substance abuse, how to create safe spaces, how the environment contributes to safer neighborhoods, and how to engage in Arts-Poetic expression to build strong self-esteem.

The South Florida Wellness Network's LETF Peer Support Re-entry Program will address crime prevention by helping adult inmates in two Broward County jails who face mental illness and/or substance addiction to learn recovery skills and resiliency strategies to prepare for community re-entry and reduce the chance of post-release recidivism. A trained Peer Specialist will facilitate weekly recovery education for peer support and pre-release planning, serving 500 duplicated group attendees and 55 inmates with one-on-one peer support. One hundred (100) individuals will receive post-release services, such as recovery support, linkage to community-based resources, follow-up, and Pen Pal correspondence. Expected outcomes include: 65% of inmates receiving re-entry services while in jail will be more prepared to deal with their mental health/substance use upon release as measured by Wellness Recovery Action Planning (WRAP) initiation; 50% of persons receiving individualized services will access eligible benefits and needed community-based services by 30 days post-release; and 70% who receive individualized post-release services will not return to jail within 90 days. LETF funding will allow continuation and enhancement of this existing service, improve access to mental health/substance use services, ease re-entry transition, and enhance peer support as a key element in BSO's detention approach.



The expected participant outcomes are: 1. 70% will remain in recovery housing for at least 30 days; 2. 75% will be employed within the first month; and 3. 70% will not be re-incarcerated within 90 days of release. SFWN has the expertise and experience in facilitating recovery residence scholarships needed to implement this program. LETF grant funds will allow the continuation of recovery residence scholarships, bus passes, incentive gift cards and successful reintegration of former inmates back into the community.
