9	WHEREAS, Section 18.61 of the Broward County Administrative Code

11	("Administrative Code") sets forth the policy for the engagement of external auditors to
12	conduct Broward County's independent annual financial audit ("External Auditor");
13	WHEREAS, the Broward County Board of County Commissioners ("Board")
14	desires to amend the provisions of Section 18.61 of the Administrative Code related to
15	the engagement of the External Auditor; and
16	WHEREAS, the Board finds that the revisions to the Administrative Code as set
17	forth herein are in the best interest of Broward County, NOW, THEREFORE,

19	BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF
20	BROWARD COUNTY, FLORIDA:

22	Section 1. Section 18.61 of the Broward County Administrative Code is hereby
23	amended to read as follows:

18.61. Independent Annual Audit.

. . .

b. The following policy shall govern the engagement of an auditor for an independent annual audit of the accounts and financial transactions of Broward County: As required by Section 218.391, Florida Statutes, the Board of County Commissioners shall establish an audit committee, in accordance with statutory requirements. The audit committee shall follow the auditor selection procedures set forth in the statute and shall rank and recommend auditors in order of preference. The Board of County Commissioners shall make the final determination in the selection of an auditor. The engagement of an auditor shall be for a five (5) year term with a mandatory change of auditors after five (5) years. If the audit committee's scoring or ranking results in a tie between an incumbent auditor that has been engaged for ten (10) or more years and another proposer, the tie shall be broken by giving preference to the nonincumbent auditor. If the County reengages an incumbent auditor, there shall be a mandatory change of the incumbent auditor's partners and managers assigned to perform the audit.

Section 2. Severability.

If any portion of this Administrative Code Resolution is determined by any court to be invalid, the invalid portion will be stricken, and such striking will not affect the validity of the remainder of this Administrative Code Resolution. If any court determines that this Administrative Code Resolution, in whole or in part, cannot be legally applied to any individual, group, entity, property, or circumstance, such determination will not affect the applicability of this Administrative Code Resolution to any other individual, group, entity, property, or circumstance.

7	such intention.
