SOLE SOURCE/SOLE BRAND REQUEST
I. REQUEST: Provide a description of the features of the product/service or Scope of Work.
Water and Wastewater Operations Division (WWOD) requests sole brand approval to purchase Vogelsang Pumps and Replacement Parts from the sole source distributor, PSI Technologies Inc. WWOD has a total of five (5) Vogelsang Pumps and three (3) Vogelsang Grinders on-line at North Regional Wastewater Treatment Plant in Pompano Beach. An open-end contract is needed to cover the maintenance and repair of the Vogelsang pumps and grinders, estimated at \$266,000 annually.
II. JUSTIFICATION: Please check all boxes that describe your reason(s) for determining that only one source or brand is reasonably available.
Only Sole Source/Uniqueness  Proprietary Item - this vendor/ source has the only rights to provide this service or commodity. A letter from
the manufacturer or authorizing entity is included in this request.

Other – the County requires this sole source, sole brand purchase for the following reasons:
WWOD requests approval to procure Vogelsang Pumps and Replacement Parts from the sole source supplier PSI Technologies Inc. Vogelsand pumps, grinders and parts are patented and owned by Vogelsang; and the design drawings are proprietary. PSI Technologies, Inc. is the exclusive distributor for municipal sales in Broward County, FL. Attached for review is a letter from Vogelsang.

	Operational Compatibility - replacement parts from alternate suppliers are not interchangeable with original part and causes equipment incompatibility. Previous findings and/or documentation is included with this request.
	Ease of Maintenance - maintenance or retooling prohibits competition. Section III, Comparative Market Research includes estimated costs associated with changing current source and/or brand.
3	Follow-On - potential for continued development or enhancement with same supplier and eliminates costs incurred by using different supplier. Section III, Comparative Market Research includes estimated costs for replacing current or existing system.

	Other/or additional information – using this sole source, sole brand purchase benefits the County for the following reasons:
	WWOD acquired a total of five (5) Vogelsang Pumps with the new Fats, Oils and Grease (FOG) Receiving Facility located at the North Regional Wastewater Treatment Plant. The FOG system is a dedicated site for the proper disposal of fats, oils and grease, a common by-product of restaurants that clog and damage sower pipes. The FOG system works together with the new Cogeneration System to produce power from biogas, so that it can be consumed internally within the plant and offset power purchased from Florida Power & Light.
	Also, there are three (3) Vogelsang grinders on-line at the NRWWTP's thickener building. These grinders are critical to the operations of the NRWWTP as thoir primary function is to reduce the particle size of solid matter, including rags, wipes, plastics, etc. which enables further wastewater processing by minimizing problems to equipment and treatment. The Vogelsang grinders protect downstream system components from damage, prevent blockages and clogging of pumps, fittings and pipe streams.

	Cost/Benefit Analysis: What would the cost be to utilize an alternate vendor or source? This explanation should include the savings and/or additional costs to the County by not using the preferred vendor or source. Attach additional sheets if needed.
	On June 26, 2012, the Board of County Commissioners approved the 'Biogas to Cogeneration Energy Project" (Item 57) which provided for the construction of both the FOG and Cogeneration System. The overall cost of the project for design and construction was \$18 million. The waste-energy system is anticipated to reduce the NRWWTP's annual energy consumption by 12,000,000 kWh and its carbon emissions by over 8,000 metric tons a year and expected to generate guaranteed savings of nearly \$27 million over the next 20 years. Replacement pumps and parts from alternate supplies are not interchangeable with original parts and may cause equipment incompatibility. The cost to design, reconfigure and test an alternate product would far outwelgh the cost to procure OEM replacement parts.

#### Known Reasonable Source/Brand

Vogelsang brand pumps, grinders, and repair parts from the manufacturer exclusive municipal distributor, PSI Technologies, Inc.

#### Justification for Reasonable Source/Brand Acquisition

Water & Wastewater Services (WWS) has five (5) Vogelsang brand pumps currently installed at the North Regional Wastewater Treatment Plant (NRWWP). These pumps are used in the Fats, Oils, and Grease (FOG) Receiving Facility. The FOG system is a dedicated site for the proper disposal of fats, oils, and grease, a common by-product of restaurants that clog and damage sewer pipes.

In addition to the five (5) pumps, there are three (3) Vogelsang brand grinders on-line at the NRWWP's thickener

building. These grinders are critical to the operations of the NRWWP as their primary function is to reduce the particle size of solid matter, including rags, wipes, plastics, etc. which enables further wastewater processing by minimizing problems to equipment and treatment. The grinders protect downstream system components from damage, prevent blockages and clogging of pumps, fittings and pipe streams.

WWS requires direct replacement pumps, grinders, and parts for the currently installed Vogelsang equipment. It is believed that Vogelsang brand pumps and grinders are proprietary. Replacement pumps, grinders, and parts from alternate brands are not interchangeable with original parts and may cause equipment incompatibility. The cost to design, reconfigure and test an alternate product would outweigh the cost to procure original equipment manufacturer replacement parts. Commissioning services may also be needed when replacement Vogelsang equipment is installed.

It is believed that the only brand of pumps, grinders, and replacement parts that can be used are Vogelsang brand. It is also believed that the sole manufacturer exclusive municipal distributor is, PSI Technologies, Inc.

If you are capable of meeting or exceeding the specification requirements for this product or equal, respond to this RFI/Notice of Intent to Designate Sole Source/Sole Brand through Periscope S2G. Provide product literature for any product to assist in determining if product is comparable. The Director of Purchasing shall have sole authority in deciding what is comparable.

Prospective Vendors are requested to provide information regarding their ability to supply the commodities or contractual services described or written explanation or other documentation contesting the proposed designation as a Sole Source/Sole Brand. Prospective Vendors will be considered only if they provide documentation demonstrating that they are capable of meeting or exceeding the specification requirements stated herein. All Vendor responses will be evaluated by the Director of Purchasing who shall have sole authority in establishing the approved equal status of the commodity or service offered by the vendor.

The Director of Purchasing shall consider such submittals and notify all submitting vendors of the decision whether to designate as a Sole Source/Brand, which decision shall not be subject to objection, protest, or appeal.
