

FIRST AMENDMENT TO THE AGREEMENT BETWEEN BROWARD COUNTY AND ADVANCED ROOFING, INC. FOR SOLAR ENERGY SERVICES

This First Amendment to the Agreement ("First Amendment") is made and entered into by and between Broward County, a political subdivision of the State of Florida ("County") and Advanced Roofing, Inc., a Florida corporation ("ARI" or "Contractor") (collectively referred to as the "Parties").

RECITALS:

- A. On December 22, 2021, the County and ARI entered into a Contract for the construction, installation, operation, and maintenance of three (3) solar energy systems at three (3) County facilities with a contract term of twenty (20) years and not-to-exceed amount of Two Million Three Hundred Sixty-Seven Thousand One Hundred Seventy-Nine and Seven Hundredths Dollars (\$2,367,179.07) ("Contract"), of which One Million Five Hundred Ninety-Five Thousand Five Hundred Twenty-One Dollars (\$1,595,521) is payable over twenty (20) years and expected to be offset by energy cost savings over the twenty (20) year life of the projects.
- B. The County has determined that installation of a solar energy system at one of the sites specified in the Contract, T.Y. Park, is not feasible and instead wishes to install a solar energy system at Reverend Samuel Delevoe Memorial Park ("Delevoe Park").
- C. The County and ARI wish to amend the Contract to provide for the installation of a solar energy system at Delevoe Park instead of T.Y. Park, and to increase the not-to-exceed amount of the contract to reflect additional costs associated with the installation of a solar energy system at Delevoe Park.
- D. The Parties have agreed to revise Schedules A.1, A.2, A.4, A.5, and A.7 to reflect the removal of the installation of a solar energy system at T.Y. Park from the Contract and the addition of the installation of a solar energy system at Delevoe Park to the Contract.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties agree to amend the Contract as follows:

- 1. <u>Recitals</u>. Each Party represents that the Recitals stated above are true and correct and are incorporated herein by reference.
- 2. Recital H of the Contract is hereby amended (words stricken through are deletions from existing text and words underlined are additions to existing text) as follows:
 - H. The Parties wish to enter into this Contract for an additional three (3) solar energy system projects at Broward County facilities at an additional not-to-exceed amount of Two Million Three Hundred Sixty-Seven Thousand One Hundred Seventy-Nine and Seven Hundredths Dollars (\$2,367,179.07) Two Million Five Hundred Eighty-Nine Thousand Seven Hundred Thirty-Eight and Six Hundredths Dollars (\$2,589,738.06) of which

One Million Five Hundred Ninety Five Thousand Five Hundred Twenty One Dollars (\$1,595,521) One Million Six Hundred Three Thousand Seventy-Nine and Ninety-Nine Hundredths Dollars (\$1,603,079.99) is payable over twenty (20) years and expected to be offset by energy cost savings over the twenty (20) year life of the projects. This Contract is entered into in reliance upon the continuation of the Director of Purchasing's approval of piggyback agreements under State of Florida Contract DMS ITN No. 08-09-029 described above.
