JUSTIFICATION:

<u>Capital Project Management Administrator</u>: The purpose of this classification is to provide high level management and oversight of substantial capital improvement projects and design development for Broward County.

<u>GIS Analyst</u>: The purpose of this classification is to provide professional work analyzing a variety of Geographic Information System (GIS) data. Duties include ensuring accuracy of mapping; managing large, dynamic GIS datasets to drive project implementation; designing and/or modifying GIS programming; coordinating GIS functions with other agencies, jurisdictions, engineers, developers, and the general public and assisting with analysis, research, design, and implementation of all mapping tools, templates, standards, and software as well as create a knowledge base of standard templates and techniques.

GIS Analyst, Senior: The purpose of this classification is to provide senior level review, interpretation, and analysis of GIS data, including designing, developing, and managing project-specific relational database applications. Will perform high-level data analysis, dashboard interface design, development of user acceptance testing (UAT) criteria and business intelligence (BI) documentation, and maintenance and management of the Enterprise ArcSDE geodatabases including configuration, tuning and database security.
