Howard,

I have had an opportunity to review materials relative to Plat No. 005-MP-Atlantica at Dania Beach; Broward County property folio(s): 5042-35-00-0260.

- A. In my capacity as the County's archaeological consultant, based on the available information including archival documents, maps, the Broward County Land Use Plan and the Florida Master Site File (FMSF), it is my determination that the proposed project will not have an adverse effect on any known historical or archaeological resources or areas of archaeological or paleontological sensitivity.
- 1. The following cultural resources were identified in a search of a 0.5-mile radius surrounding the Project Area.
  - 12 Historic Structures: all deemed Ineligible for inclusion in NRHP by SHPO.
  - 2 Resource Groups: all deemed Ineligible for inclusion in NRHP by SHPO.
- B. The subject property is located in the City of Dania Beach, outside jurisdiction of the Broward County historic preservation ordinance (B.C. Ord. 2014-32). The property owner / agent is advised to contact the municipality to seek project review for compliance with municipal historic preservation regulations.
